#### Frequently Asked Questions

Q1: If students were on the LEA's list last school year, does the LEA report the student again for this school year if they have confirmed that the student is still trying to enroll in their charter?

A1: The charter school will need to report students who are placed on a waitlist in the current school year as of the last Friday in September. If the student was on the

waitlist in the previous school year and is still on the waitlist for the current school year on the snapshot date, the student would need to be reported.

## Q2: What if a student is on a charter school waitlist and does not have a Unique ID when applying to be on the waitlist?

A2: Students on the waitlist who do not currently have a Unique ID should be assigned a UID. Every effort should be made to determine if the student has an existing UID.

- Search the UID system for the student
- Rely on any information provided by the parents or previous LEAs when searching
- Students who already have a UID should not be assigned a new UID

Program area staff at the charter school should work with the individuals who have been trained on the Unique ID system to assist in performing these searches.

# Q3: Does the charter school need to complete this data collection if they do not have a waitlist and they are not at capacity?

A3: Yes. All open-enrollment charter schools must complete the Charter School Waitlist data collection. If they are not at capacity and do not have a waitlist, they still must submit the following Education Organization data:

- E1674 NUMBER-CHARTER-STUDENTS-ENROLLED
- E1675 CHARTER-EDUCATIONAL-ENROLLMENT-CAPACITY
- E1676 CHARTER-ADMISSION-WAITLIST-INDICATOR-CODE

The data is not used in any audits.
