1. Discipline Update of Data Elements, Descriptor Tables, and Guidance Action Item Background:

During the winter of 2023, the program area audited all discipline-related data components and guidance in the Texas Education Data Standards for accuracy and alignment with Chapter 37 of the Texas Education Code. As a result of this audit, the program area requested revisions to data element definitions, descriptor tables, and guidance.

Overview:

Texas Education Data Standards Changes:

For the 2025-2026 school year, the Texas Education Agency (TEA) is proposing to update one data element definition, IncidentLocation (E1083) in the DisciplineIncident Entity. Additionally, TEA is proposing to update the short and long descriptions in two descriptor tables, IncidentLocation (C190) and Behavior (C165), as well as the Data Element Reporting Requirements in the StudentDisciplineIncidentBehaviorAssociation, and TSDS reports and data validation rules to reflect the changes in this proposal. Changes in this proposal do not impact what is reported in TSDS PEIMS.

Georgia added that the LEAs receiving those records may not know the translation, which results in additional research work for the receiving LEA. Georgia asked if the TREx discipline report could include the translations of the descriptors.

Jamie Muffoletto stated that TEA would see if the report could be updated to include the translations.

2. Sunset ATC Indicator

Action Item

Background:

The Advanced Technical Credit (ATC) Texas Program provided a pathway for high school students to begin earning college credit toward a career and technical education certificate or degree. The local education agency (LEA) had a memo of understanding (MOU) with a partnering institution of higher education (IHE) for when a student successfully completed articulated advanced technical credit (ATC) courses, the courses would transfer once the student graduated from high school and enrolled in a public Texas IHE. The Texas Education Agency (TEA) introduced the ATC-INDICATOR-CODE (E1058) (TSDS Upgrade name change to ATCIndicator) in 2009 to track high school courses awarded college credit by a post-secondary institution. As the third-party administrator, TEA utilized Perkins funding when ATC was part of Perkins IV.

During the 115th Congress (2017-2018), House of Representatives (H.R.) bill 2353 was passed and became Public Law No: 115-224. The Strengthening Career and Technical Education for the 21st Century Act (Perkins V), which amended the Carl D. Perkins Career and Technical Education Act of

2006 (Perkins IV), was signed into law on July 31, 2018. Perkins V removed funding for the ATC program and updated the credit transfer agreement, indicating that a student can take CTE courses for dual credit and credit is granted based on performance. As a result, the ATC program was phased out, with the last ATC courses being offered in 2018-2019. Beginning with the 2019-2020 school year, LEAs should not have reported this indicator. The program area has requested the data element be sunset for the 2025-2026 school year.

Overview:

Texas Education Data Standards Changes:

For the 2025-2026 school year, the TEA is proposing to sunset the data element, E1058 ATCIndicator. The data element will be removed from the CourseTranscript Entity. Additionally, reports will be updated, and guidance and data validations will be removed.

3. Special Education Data Collection

Action Item

Background:

Each state is required to develop a six-year performance plan that evaluates the state's efforts to implement the requirements and purposes of the Individuals with Disabilities Education Act of 2004 (IDEA 2004), Section 616(b). The State Performance Plan (SPP) illustrates how the state will continuously improve upon this implementation and includes updates through the Annual Performance Report (APR) submitted annually each February.

In alignment with IDEA, the US Department of Education Office of Special Education Programs (ED/OSEP) identifies five monitoring priorities within the SPP, and 18 indicators associated with these monitoring priorities.

 - Graduation (Indicator 1)
 - Dropout (Indicator 2)
 - o Participation and Performance on Statewide Assessment (Indicator 3A-C)

 - Educational Environment, Ages 3-5 (Indicator 6A-B)
 - Early Childhood Outcomes (Indicator 7A-C)
 - Parent Participation (Indicator 8)
- Monitoring Priority: Disproportionality
 - Disproportionality in the special education program (Indicator 9)
 - Disproportionality by specific disability (Indicator 10)
- Monitoring Priority: Effective General Supervision Part B/Child Find
 - Child Find (Indicator 11)
- Monitoring Priority: Effective General Supervision Part B/Effective Transition
 - Early Childhood Transition (Indicator 12)
 - Secondary Transition (Indicator 13)
 - Post-School Outcomes (Indicator 14A-C)
- Monitoring Priority: Effective General Supervision Part B/General Supervision
 - Resolution Sessions (Indicator 15)
 - Mediation (Indicator 16)

Indicators 1, 2, 5, 6, 9, and 10 use data collected in the PEIMS Fall Submission.

Indicator 3 uses data from the statewide assessment program.

Indicator 4 uses data collected in the PEIMS Summer Submission.

Indicator 7 uses data collected through the SPP 7 application in the Texas Education Agency Login (TEAL).

Indicator 8 uses data collected through a spring Texas Parent Involvement Survey.

Indicators 11 and 12 uses data collected in the Child Find Collection.

Indicator 13 uses data collected through the SPP 13 application in TEAL.

Indicator 14 uses data collected in the SPPI-14 Collection.

Indicators 15, 16, 17, and 18 are measured at the state level. There are no local education agency reporting of data.

Overview:

The Texas Education Agency (TEA) proposes adding a new core collection, Special Education Data Collection, beginning in the 2025-2026 school year. The new collection would initially consist of SPPI 7, 11, 12, and 13 data. The SPED Summer Submission would be due the last Thursday in July.

SPPI-7 measures the demonstrated improvement for preschool children aged three through five with Individualized Education Programs (IEPs) in the following areas:

- 1. Positive social-emotional skills (including social relationships).
- 2. Acquisition and use of knowledge and skills (including early language/communication and early literacy); and
- 3. Use of appropriate behaviors to meet their needs.

Local education agencies (LEAs) utilize the Childhood Outcomes Summary (COS) Process to document children's progress in the three outcomes. LEAs report these outcomes using a specific rating category on a seven-point scale at entry and exit of all students aged three through five (not in kindergarten) who receive early childhood special education (ECSE) services for six months or more during the school year.

SPPI-13 measures the percentage of youth with IEPs aged 16 up to age 21 with an IEP that includes:

- Appropriate measurable postsecondary goals that are annually updated and based upon an age-appropriate transition assessment;
- Transition services, including courses of study, that will reasonably enable the student to meet those postsecondary goals and
- Annual IEP goals related to the student's transition service needs.

Additionally, there must be documented evidence that the student was invited to the admission, review, and dismissal (ARD) committee meeting where transition services are to be discussed and evidence that, if appropriate, a representative of any participating agency that is likely to be responsible for providing or paying for transition services was invited to the ARD meeting with the prior consent of the parent or student who has reached the age of majority.

SPPI 11 and 12 are currently collected through the Child Find Collection. The Child Find Collection would be removed and all data elements in the current collection would be moved to the Special Education Data Collection.

Timeframe:

The annual data collection for SPPI 7, 11, 12, and 13 is July 1st to June 30th of a given year. The table below represents the due dates for the SPED Summer Submission:

ITF Discussion:

Jamie Muffoletto introduced Donna Homes and Susan Bineham from the Special Populations Strategic Support and Reporting Department to address any questions.

Keitha Ivey asked the program area to clarify the difference between ECSEServiceExitReason descriptors, Moved From The LEA Before Meeting Exit Criteria (03), and Child Transferred Out Of State (05).

Donna stated that the LEA has different responsibilities for reporting students in SPPI-7 depending on the ECSEServiceExitReason selected.

Donna added that if a student transfers to another LEA within the state, the LEA would report using descriptor 03, Moved From The LEA Before Meeting Exit Criteria. Reporting the student using the 03 provides the TEA program area with information that another LEA should report the student with the StudentEarlyChildhoodOutcomesExitSet.

When a student moves out of state, Donna added that LEAs would report using descriptor 05, Child Transferred Out of State. Reporting the student using the 05 provides the TEA program area with information that no additional data would be reported for the student since they left Texas public education.

Keitha was concerned that a diagnostician would not know some of the data in the new SPED Summer Submission and asked if there are differences between it and the existing submission through the SPP application in TEAL. Donna stated that there is no change in the data being reported.

Susan confirmed the data collected for SPPI-7 is not new and is currently being reported using the SPP application in TEAL.

Donna confirmed moving SPPI-7 to TSDS will require additional training. Adding additional data validations in TSDS should help the LEA determine which students need to be reported.

Jamie confirmed validation rules and reports would be added to TSDS to help determine which students should be reported for the new submission.

Jamie added that the proposed new core collection, Special Education Data Collection, beginning in the 2025-2026 school year would be comprised of special education data divided into submissions. The first submission would be the SPED Summer Submission and would consist of SPPI 7, 11, 12, and 13 data. The goal would be for the special education program area to be responsible for these new submissions.

Keitha Ivey asked Jamie to repeat the timeline from the proposal. Jamie displayed the timeline and stated the submission would begin with the 2025-2026 school year.

Keitha requested confirmation that in the 2025-2026 school year, LEAs also begin reporting leavers and graduates in the PEIMS Summer and Extended-year Submissions. Lauran Price asked to clarify if the new SPED Summer Submission would be due at the same time as the changes to leavers and graduates. Jamie stated that the new SPED Summer Submission would be due for the first time in July 2026 (2025-2026 school year). The changes to leavers and graduates would also begin in the 2025-2026 school year.

Catherine Bray asked if any ECSE data needs to be included in TREx. Donna stated that when the student transfers to a new LEA, the new LEA would not need to report another ECSE entry record to TEA.

Jamie added that the ECSE paperwork is transferred in TREx as an attachment as part of the student special education record. While the information is provided to the new LEA, the new LEA does not need to report it to TEA again.

Catherine asked if the new SPED Summer Submission would have rules or reports to determine if a student has an ECSE entry but was not reported in the SPED Summer Submission with entry information. Donna proposed adding a report showing an LEA if a student has an ECSE entry but has not been reported in the new SPED Summer Submission yet.

Jamie added the new SPED Collection reports, created in TSDS, would provide the ECSE data LEAs need to decide which students to include.

Donna added that the TEA program area has heard concerns from the LEAs and would work with the LEA program area to train staff before implementation to support a smooth transition from the SPP application in TEAL to TSDS.

Catherine stated that financial costs need to be taken into consideration when having a diagnostician enter the student data during the summer. Jamie stated that the student data is currently being entered into the SPP application in TEAL during the summer.

Elisa Sanchez asked when TEA would release the TAA. Jamie stated that the initial TAA would be released when TEA publishes the new submission in the 2025-2026 Preliminary Texas Education Data Standards publication. Additional TAAs would be released as needed by the program area.

Traci asked TEA to add a discussion from the commissioner to superintendents about the PEIMS coordinator position and the new SPED Collection to the communication plan. Traci added that when something new is added to TSDS, it gets added to the workload of the PEIMS coordinator, not the program area.

Melody Parrish, Deputy Commissioner of Technology, shared that she would discuss with the commissioner, including the topic in a Superintendent call. Traci informed Melody she would

volunteer to be on the call. Catherine Bray asked if TEA could add a new role to AskTED for a SPED PEIMS Coordinator. Jamie thanked Catherine for the suggestion.

Jamie Muffoletto, called for additional questions or comments. Hearing none, she requested a motion.

On Time Federal Reporting

Traci Pesina asked about the proposed changes to the On-Time Federal Reporting and wanted to propose a different solution for the "as of date" in the new PEIMS Fall Enrollment Submission Proposal. Jamie stated that since the discussion pertained to On-Time Federal Reporting, she asked Traci to email this to her for consideration.

TREx Student Record Fulfillment

Georgia Kalligeris stated that some LEAs are not fulfilling the TREx student record requests during the summer months. The LEAs state they can only process the TREx requests when the school year begins. Georgia requested feedback from attendees if anyone knew why this would occur. Lauren Price stated the staff trained on fulfilling TREx requests are only present ten months out of the school year and thus may not be present during summer. Lauren added that Houston ISD shuts down their

student information system to roll over data into the new school year. During that time, the student records are inaccessible. Georgia thanked Lauren for her feedback. Jamie acknowledged Georgia's concern and would look at what could be added, if anything, to the TREx standards. Georgia added that reminders were sent to the LEAs and escalations were sent to the TREx generic mailbox. Jamie stated she would investigate Georgia's concerns.

Traci Pesina made a motion to adjourn. Georgia Kalligeris seconded the motion.
