Though the McKinney Vento Homeless Assistance Act (42 U.S.C. 11431 et seq.) pertains to children and youth, for this data collection, we will use the same definition for staff that experienced homelessness due to Harvey.

The McKinney Vento Act defines children and youth who lack fixed, regular, and adequate nighttime residence, including children and youth:

- Sharing the housing of other persons due to loss of housing, economic hardship, or similar reason
- Living in motels, hotels, trailer parks, or camping grounds, due to the lack of alternative adequate accommodations
- Living in emergency or transitional shelters, or are abandoned in hospitals
- Living in a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings
- Living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings
- Migratory children living in the above circumstances.

Therefore, any teaching staff who met the definition in the first five bullets above would be reported in this collection.
