PEIMS	Data Promotion	<p>All budget information is being promoted, including fund codes that are not valid and amendments to the budget made after the PEIMS Fall snapshot date.</p> <p>TEA will be updating the data promotion logic for the Finance &gt; Budget subcategory for the PEIMS Fall Data Collection that excludes the invalid data. Production & Staging API	ResultDatatypeType Descriptor	The ResultDatatypeType descriptor for data element ResultDatatypeType (E3052) is not included in the Production or Staging API. Vendors will not be able to send this data until the TEDS 2024.2.1 changes are implemented in the parallel environment.  Workaround: ECDS assessment vendors can utilize the SDK version 2024.2.0 for development and testing until the parallel environment is updated to TEDS 2024.2.1.	09/12/23	TBD
